Enclosed is a breakdown of Cutter's sales to TST over the past eight years. I hope it will be of some help to you in analyzing trends in your market and assessing the success of some of your sales programs.

Despite loss of your Cutter I.V. solution business, TST's Cutter sales reached a record high in 1984. During 1984, TST bought \$1.7 million worth of Cutter products (\$1,032,652 worth of plasma products and \$665,350 worth of I.V. and blood sets).

Koate® and Konyne® sales have shown consistent growth since 1977. Let's hope we can sustain that business with no difficulties from product registration delays on heat-treated concentrates.

Gamastan® sales appear to have leveled off. Last year you were going to check on competitive pricing of gamma globulin and let me know what we could do to take over more of that market. Keep us informed of any new ideas you have on the matter.

HyperHep® sales should enjoy continued increase this year. I have just noted in a report on the Korean pharmaceutical market that, during 1983, Korea imported \$4.7 million worth of hepatitis B vaccine and Korea Green Cross produced an additional \$6 million worth in Korea. If the Korean vaccine market has exceeded \$10 million a year, the HBIG market is guite high also. Taiwan will probably use more and more HB vaccine and HBIG each year for the next few years.

Let's hope that we can get Gamimune® introduced into the R.O.C. market with success this year. We expect it will become an important component of TST's sales within a few years.

On the I.V. set business, let's work closely together this year to build increased sales. As Jim Davis said to you, we are now able to react more quickly to any special needs TST may have. Our reduced sales volume and single production facility allow
