Dan, Scott, and Mike-

As you probably know, due to budget limitations we originally limited our IARC prep efforts to two Medical Toxicologists- Bill Banner and Michael Greenberg (tough choice honestly- all of you guys are fantastic and know something about the product- Bill and Michael G. happened to have some fairly recent involvement.)

It now appears that the IARC decision will be released sometime between this Thursday evening and Monday AM (March 23) in Lancet Oncology. We have reason to believe that (to our amazement, frankly given recent assessments by EPA and in the EU) that they are going to label glyphosate a 2A Probable Human Carcinogen.

I now have some extra budgetary resources- I can put \$5000 each toward review of the relevant literature- which I now have in highly organized form. The catch is that we would ideally need you to be ready to take inquiries from media and other parties as soon as Friday of this week- although I would be happy to give folks the weekend as well if they can be prepared by Monday as the issue will likely require attention for several weeks or months. We would (as noted in original e-mail below) not pay for media contacts- but happy to pay for review time.

**PLEASE LET ME KNOW ASAP IF YOU ARE INTERESTED-** I will get you a drop-box link for the literature. (Scott- I think you may have the old link.... I have a new file that is far better assembled)

**We have an urgent issue and we may need to have several medical toxicologists review this in preparation for an IARC meeting and decision on glyphosate expected on or about March 10, 2015.** I know you are familiar with the evaluation of epidemiology and animal/mechanistic data and have experience dealing with media and other stakeholders like American Cancer Society or ACSH as theoretical examples, if they wish to engage on the issue.

In view of the effort needed and the time frame, it is obvious we will need to pay people for their time needed to review/prepare on the subject. We would not pay for media interviews or other interactions. We realize that you will need to be entirely transparent about any funding for your invested effort and fully support this level of transparency.

**If you think you might have time to fit this in (details below), please let me know so we can begin to look at consulting rates, etc.** If so, I would like to provide you the full set of materials. This will include all the relevant scientific papers as well as several review on the subject and commentary (published or not) from various experts.
